2022 City of Berea Business Grant Programs and Application

All applicants will be required to provide an **Occupancy Permit, a Business Plan or Marketing Plan, and an estimate of costs at the time of submitting this Grant Application.** In addition, specific grant programs may require additional information to be submitted at the time of application, please see below. **Applications that do not include all required documents will not be considered.** Further, an explanation of expenditures including invoices and proof of payment, completed IRS W-9 form, Berea New Vendor Form and any other program specific documents listed below are required before reimbursement funds can be disbursed. All funds are conditioned upon compliance with the City of Berea Exterior Maintenance Code, Zoning Code, other related codes and obtaining permits when applicable. Failure to abide by the City of Berea Exterior Maintenance Code, Zoning Code and related codes or to obtain all necessary permits will result in forfeiture of grant funds.

- **Building Improvement Program:** Interior and/or exterior building improvements or permanent fixtures purchased within 365 days of the date the 2022 Grant Application is filed can be considered for reimbursement of 15% of the total project cost up to \$7,500. Businesses that did not use the Building Improvement Program during calendar year 2021 are eligible to apply. Copies of invoices, proof of payment and a spreadsheet explaining how all items purchased were used for the building improvement are all required for reimbursement. Business must obtain all necessary permits including: building, electrical, HVAC, plumbing, zoning, or related in order to be eligible for reimbursement. This program is citywide and has limited funds.
- **Signage Assistance Program:** Installation of new permanent exterior signage may be eligible to receive a rebate of 50% of the cost of the signage, not to exceed \$1,600. All permanent exterior signage must be approved by the Berea Municipal Planning Commission and if applicable the Heritage Architectural Review Board. A building permit is required for all permanent exterior signs. This program is citywide and has limited funds.
- **Rent Reimbursement Program:** Businesses that have been operating in Berea for up to two years or are able to demonstrate a hardship are eligible to apply for a 15% reimbursement of the monthly rent for each month of the 2022 calendar year (2021 and/or 2023 rent is not eligible). The 15% reimbursement shall not exceed \$450.00 per month. Businesses must be current on all rent payments to be eligible. Common area maintenance, taxes, insurance and similar fees due under a lease are NOT eligible for reimbursement. A signed copy of the lease must be included with the Grant Application. In order to be considered for a hardship, the business must submit a letter and any necessary supporting documentation at the time of application. This program is citywide and has limited funds.

- **BW Digital Marketing Clinic Grant:** Both existing and new Berea businesses are eligible to apply for the BW Digital Marketing Clinic Grant. Pursuant to the terms of this grant, the City of Berea will reimburse up to \$1,500 of the cost of participating in the Digital Marketing Clinic (“DMC”). In most instances participation in the DMC does not exceed \$1,500. A Commitment Letter agreeing to retain the business in the City of Berea for 5 years must be submitted at the time of the grant application. An invoice from the BW DMC and proof of payment to BW are required at the time of reimbursement. This program is citywide and has limited funds.
- **BW Sustainability Consulting Grant:** Both existing and new Berea businesses are eligible to apply for the BW Sustainability Consulting Grant. Under the terms of this grant, the City of Berea will reimburse the business for the cost of BW's Sustainability Clinic consulting services up to \$250 for a feasibility study and \$1,750 for a detailed sustainability plan. These services employ small teams of trained faculty and sustainability student consultants who work with businesses to enhance sustainability performance in four areas: Energy conservation and clean energy; Waste reduction strategies; Development of green and sustainable product and services; and Energy Treasure Hunts. A Commitment Letter agreeing to retain the business in the City of Berea for 5 years must be submitted at the time of application. An invoice from the BW Sustainability Clinic and proof of payment to BW are required at the time of reimbursement. This program is citywide and has limited funds.
- **Hood Installation Program:** When installing or rehabilitating a commercial kitchen hood ventilation system, the City of Berea will reimburse a business 50% of the cost of the hood up to \$5,000. Reimbursement is contingent upon the business securing all necessary permits and inspections for installation of the hood from the Berea Building Department. This program is citywide and has limited funds.
