**\*LEASING REQUIREMENTS AND REGULATIONS\***

A Leasing Permit is required except in cases where **a person whose name is on the deed** resides in the dwelling unit. No owner, renter, tenant or regular occupant of any single family or two family dwelling shall rent, lease, or regularly occupy a dwelling unit without first obtaining a Leasing Permit. A dwelling, subject to the leasing permit ordinance, may not be occupied until a permit is obtained. Each dwelling unit may be occupied by a family (related by blood, marriage or adoption) – or – by no more than **three** unrelated persons.

Owners may be cited for failing to apply for a permit. Occupants may be cited for occupying the dwelling without a permit. Either party, upon conviction, is guilty of a misdemeanor of the fourth degree.

The owner is required to provide the names of the occupants, the number of occupants that will occupy the dwelling, the number of motor vehicles regularly used by the prospective occupants, and the make, model and license plate numbers of all vehicles regularly parked in the off-street parking area that is the subject of the Leasing Permit. Once a permit is issued, the owner or occupant is required to notify the City if there is a change in occupants or vehicles.

The City of Berea Building Department will inspect each dwelling unit to determine whether the unit is of adequate size for the proposed number of occupants; whether the off-street parking area is adequate to accommodate the proposed number of motor vehicles; whether the unit and its exterior comply with the Exterior Property Maintenance Code; and whether the unit satisfies the provisions of Part Thirteen of the Codified Ordinances of the City of Berea.

A leasing permit is valid from the date of issuance to September 30th of each year. Owners are required to obtain a permit each leasing cycle (October 1<sup>st</sup>-September 30<sup>th</sup>), however inspections are only conducted every other leasing cycle.
