**HONORING THE LIFE OF MARY H. ASHBROOK AND RECOGNIZING HER
TREMENDOUS INFLUENCE ON, AND SIGNIFICANT CONTRIBUTION TO, THE
CITY OF BERE A, OHIO.**

WHEREAS, Mary H. Ashbrook was elected to City Council in 1978; and

WHEREAS, Mary H. Ashbrook served 5 consecutive terms as a distinguished member of City Council; and

WHEREAS, Mary H. Ashbrook assumed the role of President of Council in 1986 and was thereafter elected to three additional terms as Council President; and

WHEREAS, Mary H. Ashbrook tirelessly served the citizens of Berea through her involvement in the Berea Area Council on Human Relations, Berea Board of Ethics, Berea Community Center, Youth Emergency Aid, Summer Youth Employment Program, League of Women Voters, Berea Arts Fest, Berea Area Historical Society, Berea News Sun, Berea Democratic Club, and Greater Cleveland Suburban Council Association; and

WHEREAS, Mary H. Ashbrook was a lifelong advocate for civic involvement, a true champion of human rights, and a fervent leader throughout the community; and

WHEREAS, the City of Berea does hereby deem it appropriate to recognize the grand significance of a life well lived, offer our deepest and most sincere condolences to her family and friends, and extend our tremendous appreciation, gratitude, and respect to a woman who dedicated so much of her life to the City that she loved, and made us all the better for it.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Berea, State of Ohio:



SECTION 3. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.




