ORDINANCE No. 2014-51

AN ORDINANCE

AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR BIDS AND ENTER INTO ONE OR MORE CONTRACTS FOR THE RECONSTRUCTION, IMPROVEMENT, REPAIR AND REPLACEMENT OF SECTIONS OF THE CITY WATER DISTRIBUTION SYSTEM IN AND ALONG SECTIONS OF BARRETT ROAD, AND DECLARING AN EMERGENCY.

WHEREAS, an area of the city surrounding Barrett Road is served by a water main which, in some areas, has deteriorated so severely that it requires significant reconstruction, improvement, repair and replacement; and

WHEREAS, the City Council and administration find that reconstruction, improvement, repair and replacement is needed for the water distribution system along sections of Barrett Road; and

WHEREAS, this City Council, as a part of its 2014 budget, has budgeted funds for this work.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Berea, State of Ohio:

SECTION 1. That the Director of Public Service be and hereby is authorized and directed to advertise for bids, and after approval by the Board of Control, to enter into one or more contracts with the lowest most responsive and responsible bidder(s) for reconstruction, improvement, repair and replacement of sections of the water distribution system along Barrett Road in accordance with the plans and specifications on file in the office of the City Engineer.

SECTION 2. That the Director of Finance be and hereby is authorized and directed to pay out such contract sum and charge the same to, and the funds therefore are hereby appropriated from the Water Capital Improvement Fund designated for accounting purposes as Fund No. 440 for the purpose(s) set forth in Section 1 hereinabove.

SECTION 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, or providing for the usual daily operation of a municipal department, and for the further reason that in order to obtain the most favorable rate for this much needed project, early advertising and award is needed. Further, this project should begin at a date in the late summer or early fall season so as to maximize repair time. Therefore, provided this
