## AN ORDINANCE

### AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR AND SELL AT PUBLIC AUCTION CERTAIN PERSONAL PROPERTY AND VARIOUS ITEMS OF OBSOLETE EQUIPMENT NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE, AND DECLARING AN EMERGENCY.

**WHEREAS**, it is in the best interests of the City to dispose of obsolete City personal property that is no longer needed for any municipal purpose and dispose of certain unclaimed personal property held by the City.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the Director of Public Service be and hereby is authorized and directed to prepare a list of obsolete equipment no longer needed for any municipal purpose, as well as unclaimed personal property held by the City, to advertise for the public auction of same and to sell the same at auction, all in accordance with the provisions of Ohio Revised Code Section 721.15, said property being identified on Exhibit "A" attached hereto.

**SECTION 2.** That the funds received as proceeds of the sale of such items shall be received into the General Fund of the City.

**SECTION 3.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare, or providing for the usual daily operation of a municipal department, and for the further reason that it is immediately necessary to clear out needed City storage areas. Therefore, provided this Ordinance receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
