

MEMBERSHIP INFORMATION - BEREA RESIDENTS

- Berea residents are required to show (2) items as proof of residency for all new memberships and renewals.
- Acceptable forms of proof of residency include a photo ID, mail addressed to you at your Berea home (non-junk) and/or an imprinted check.
- We reserve the right to require a birth certificate as age verification.
- In order to receive an “additional member” rate, all parties must be related by blood or marriage and reside in the same household. We reserve the right to require a marriage certificate to verify eligibility.
- In order to receive an “additional member” rate, all memberships must be purchased at the same time. No exceptions.
- Memberships are **NON-REFUNDABLE** and **NON-TRANSFERABLE**.
- Members are required to abide by the rules of conduct while in the Recreation Center. Memberships may be suspended or revoked for rule violations. Rules are posted on the web site and on the bulletin board in the lobby.
- Guests are permitted upon payment of a guest fee.
- Members of the Recreation Center are entitled to “member rates” on designated programs.
- The Recreation Center is not responsible for lost or damaged property. Members and guests are strongly urged to lock their belongings while in the Recreation Center.
- Clothes, towels and other similar items are held for 30 days, and then donated to a local charity. Items of value, such as telephones, eye glasses, locks, music devices, etc. are held and sold at public auction in accordance with state law.
- On school nights, all children ages 14 and under are required to leave the Recreation Center, unless participating in a Recreation Center program or directly supervised by a parent. During vacation periods, the rule is waived.
- The indoor pool closes 30 minutes before the closing of the facility.
- The Recreation Center communicates with members primarily through e-mail. Please update your email address when necessary in order that you receive facility and program updates.
- Memberships, hours of operation, programs and rules are subject to change at any time.
