**HONORING AND COMMENDING RICHARD T. MALOTT
FOR HIS MANY YEARS OF SERVICE TO THE CITY OF BEREHA
AS A MEMBER OF BEREHA CITY COUNCIL.**

WHEREAS, Richard T. Malott has served the City of Bereha and its residents with purpose, enthusiasm and dedication as an At-Large Representative to City Council from November 1991 to January 2004, Council President from January 2004 to January 2008, and Ward 5 Councilman from January 2010 to January 2016, fulfilling 11 terms and 22 years in office; and

WHEREAS, Mr. Malott put his talents and expertise to work during his tenure in office as Chairman of the Coordinating Committee, Finance Committee, Cable TV Committee, Public Safety and Service Committee and Economic Development Committee; and

WHEREAS, Mr. Malott, in addition to his devoted service to City Council, was also active in the Bereha Kiwanis Club and served as the President of the Bereha Historical Society; and

WHEREAS, when asked how best to describe Mr. Malott, his colleagues on Council and in the Administration responded by stating he is a man of integrity and dedication, an even-keeled peace keeper and arbitrator, a selfless, tireless and steadfast patriot, a kind-hearted soul and an awesome friend; and

WHEREAS, the Members of City Council will miss the skill, competence, experience, curiosity, accessibility, humor and work ethic provided by Mr. Malott during his 22 years in office, and desire to thank him, most sincerely, for his tireless service to the community as a member of Bereha City Council.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Bereha, State of Ohio:


SECTION 2. That this Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.


