AN ORDINANCE

AMENDING SECTION 181.02, ELECTED OFFICIALS, OF CHAPTER 181, COMPENSATION AND CLASSIFICATION FOR SPECIFIC POSITIONS, OF THE CODIFIED ORDINANCES OF THE CITY OF BEREA, TO PROVIDE FOR COMPENSATION FOR ELECTED OFFICIALS FOR TERMS OF OFFICE COMMENCING IN JANUARY 2020.

WHEREAS, the maintenance of honest, effective and efficient government is best served by the establishment of an appropriate compensation structure for the holders of elective public office; and

WHEREAS, the Charter of the City imposes upon Council the duty to establish the compensation for elected offices and requires that the same be established prior to the filing deadline for persons seeking such elective offices and commencing after the election for such offices: and

WHEREAS, persons elected by the electors of the City to serve as members of City Council, Council President or Mayor are called upon to give extensively of their time, talents and efforts in carrying out their respective duties; and

WHEREAS, it is necessary, equitable, proper and right to compensate such elected public servants in a manner commensurate with the responsibilities and demands attendant with such offices and the level of services required to be performed and, in particular, to provide a continued incentive to the maintenance of efficient, effective and honest representative government in the City of Berea, Ohio, and to encourage and attract highly-qualified residents of the community to seek and hold these important high public offices.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Berea, State of Ohio:

SECTION 1. That current Section 181.02 of the Codified Ordinances of the City of Berea, which currently reads as follows:

181.02 ELECTED OFFICIALS

(a) Mayor.

For the four-year term of Office of Mayor of the City of Berea, Ohio, as a result of election to such Office in the November 2015 Election, said office commencing in January, 2016, the annual salary of the Mayor shall be:

In addition to the annual salary provided herein, the Mayor, at the Mayor's option, shall receive the unlimited use of a City-owned or City-leased vehicle having a monthly cost not to exceed Six Hundred Dollars (\$600.00) per month (and insured by the City) or in lieu thereof, the Mayor shall receive a monthly car allowance directly in the amount of Six Hundred Fifty Dollars (\$650.00) per month.

In addition to the above, the Mayor shall be entitled to all other employee benefits established in Chapter 183 of the Codified Ordinances of the City of Berea, all effective upon taking office, and any modifications of such benefits, at any time, shall not constitute either an increase or decrease of salary during a term of office; and further the Mayor shall be entitled to a minimum of

(3) three weeks vacation each year for the first four years in office, and a minimum of (4) four weeks vacation each year in any second or subsequent term of office, all administered in accordance with Section 183.09 of the Codified Ordinances.

(b) President of Council and Members of Council.

For the two-year terms of office of Council President and Members of Council, as a result of election to such offices in the November 2015 and November 2017 Elections, respectively, said offices commencing in January 2016 and January 2018, respectively, the annual salaries for such offices shall be:

181.02 ELECTED OFFICIALS

(a) Mayor.

For the four-year term of Office of Mayor of the City of Berea, Ohio, as a result of election to such Office in the November 2019 Election, said office commencing in January, 2020, the annual salary of the Mayor shall be:

In addition to the annual salary provided herein, the Mayor, at the Mayor's option, shall receive the unlimited use of a City-owned or City-leased vehicle having a monthly cost not to exceed Six Hundred Dollars (\$600.00) per month (and insured by the City) or in lieu thereof, the Mayor shall receive a monthly car allowance directly in the amount of Six Hundred Fifty Dollars (\$650.00) per month.

In addition to the above, the Mayor shall be entitled to all other employee benefits established in Chapter 183 of the Codified Ordinances of the City of Berea, all effective upon taking office, and any modifications of such benefits, at any time, shall not constitute either an increase or decrease of salary during a term of office; and further the Mayor shall be entitled to a minimum of (4) four weeks vacation each year for the first four years in office, and a minimum of (6) six weeks vacation each year in any second or subsequent term of office, all administered in accordance with Section 183.09 of the Codified Ordinances.

For the two-year terms of office of Council President and Members of Council, as a result of election to such offices in the November 2019 and November 2021 Elections, respectively, said offices commencing in January 2020 and January 2022, respectively, the annual salaries for such offices shall be:

SECTION 2. That former Section 181.02, previously amended and adopted in 2014, is hereby expressly repealed and replaced by said new Section 181.02, but subject to the operational and full force and effect provisions contained in Section 3 hereinafter.

SECTION 3. That the provisions of this Ordinance shall become operational and have application of full force and effect, and shall be applicable to the persons holding the offices of Mayor, Council President and Members of City Council, respectively, as a result of their election, certification, qualification and installation to their respective offices as a result of the November 2019 Election, and terms of office commencing in January, 2020, and that up to and until such time, the provisions of Section 181.02, as amended and adopted in 2014, shall remain in full force and effect.

SECTION 4. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
