

# RESOLUTION NO. 2023-22

## A RESOLUTION

**ACKNOWLEDGING AND CELEBRATING THAT THE STREET CURRENTLY KNOWN AS MAPLE AVENUE SHALL RECEIVE THE HONORARY, SECONDARY NAME OF "FUDALE WAY" IN HONOR OF JAMES (JIM) FUDALE, AND IN RECOGNITION OF THE WAY HE, FOR DECADES, MASTERFULLY AND INFLUENTIALLY DIRECTED THE BEREA HIGH SCHOOL BAND PROGRAM, INSPIRING COUNTLESS STUDENT PERFORMERS AND COMMUNITY MEMBERS ALIKE, AND TRULY DEFINING THE CULTURE OF A HIGH SCHOOL MUSIC PROGRAM THAT CONTINUES TO DISTINGUISH ITSELF AS THE PRIDE OF BEREA.**

**WHEREAS**, James (Jim) J. Fudale was born in 1932 in Maynard, Ohio and, after graduating from high school, spent two years in the United States Navy before attending Kent State University where he graduated with a Bachelor of Science degree and, subsequently, a Masters in Education; and

**WHEREAS**, Mr. Fudale made his home in Berea in 1963 with his wife, Jackie, and children Jean, Jim, Joe, Jeff and Jody, and is now the proud Grandfather of 9 and Great-Grandfather of 6; and

**WHEREAS**, Mr. Fudale began his career in the Berea City School District in 1963, serving as Midpark High School's first band director, and remaining in that position for 11 years until he assumed an Administrative role at Berea High School, before being named Director of Bands; and

**WHEREAS**, during his tenure at Berea High School, Mr. Fudale was responsible for the Symphonic Winds, Symphonic Band, Concert Band, Jazz Ensemble and small ensembles, and both symphonic bands, as well as the "Pride of Berea" Marching Band, which received State and National recognition for excellence in performing while under his direction and, in addition to civic and educational events throughout the City and District, performed at Cleveland Browns games, for U.S. Presidents, and at Disney World; and

**WHEREAS**, Mr. Fudale's innovation and efforts have been credited with transforming the high school band program, both educationally and financially, namely in establishing the Band Boosters as a 501(c)(3) non-profit, introducing the legendary Hoagie Drive, and instituting the honors option for the high school music curriculum, a model concept that was presented at the Ohio Music Education Association Convention; and

**WHEREAS**, in 1993, Mr. Fudale, and it could be argued his devoted wife, Jackie, who was instrumental in his success and passionately by his side through it all, retired from the Berea City School District after a career that spanned 36 influential and impressive years; and

**WHEREAS**, outside the classroom, Mr. Fudale continued to inspire musicians of all ages, organizing the Berea Community Band which provided residents the opportunity to continue performing as part of an ensemble that was featured during the Summer Concert Series for 17 seasons; and

**WHEREAS**, it is well known and acknowledged by all who enter the Berea-Midpark Music Program that, on a daily basis, the band is encouraged and expected to operate and perform to a standard described as the *Fudale Way*, and thus it is both fitting and appropriate that Mayor Kleem, Council President Maxwell and the members of Berea City Council wish to honor legendary Berea Band Director Jim Fudale by designating Maple Avenue, the way the band marches to the stadium, as "Fudale Way", in recognition of decades of musical inspiration that has brought so much pride to the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Berea, State of Ohio:

**SECTION 1.** That the President and all Members of Council, the Mayor and the Members of the Administration, do acknowledge and celebrate that, in accordance with Ordinance No. ~~2022-21~~<sup>2023-21</sup>, the street currently known as Maple Avenue shall hereby receive the honorary, secondary name of "Fudale Way" in honor of James (Jim) Fudale, and in recognition of the way he, for decades, masterfully and influentially directed the Berea High School Band Program, inspiring countless student performers and community members alike, and truly defining the culture of a high school music program that continues to distinguish itself as the pride of Berea.




