Instructions and Explanation of Fees

All applications for parades &/or Run/Walks are required to have a map provided with the application. After review of your application, applicant will be contacted about other possible requirements and fees incurred for city provided services, as explained below.

Security/Traffic Control

Any event that requires a city police officer to provide security &/or traffic control will be invoiced for the number of officers used at a rate of \$150.00 per officer per three hour increment. All fees invoiced need to be paid before the permit will be issued.

Fireworks

Events that are approved to show fireworks will be invoiced for the time used by city fire personnel to inspect, observe, and supervise the display. The rate is \$150.00 per firefighter per three hour increment. All fees invoiced are required to be paid before the permit will be issued.

Waiver of fees

In order to apply for a waiver of fees, your event must **substantially** benefit Berea residents or a Berea organization. There is no guarantee that your fees will be waived. You must submit a written appeal, addressed to the Mayor, and attach to this application. In your appeal, you must explain, in detail, why you believe that you deserve a waiver of fees.

Once the application is reviewed and pre-approved, the applicant will be contacted by phone or email with the costs associated with the event. If the applicant agrees to those terms, an invoice will be issued. Once payment is received, a permit will then be issued.
